Shinichiro Ishikawa is a leading figure in the Japanese animation industry and the Founder and CEO of GONZO, leading animation studio known for producing iconic TV series such as Hellsing, Gantz, and the Emmy Award-winning Afro Samurai. Gonzo owns more than 50 titles line up of TV series and feature films, which makes Gonzo as a distinctive player in the international media market. With a deep understanding of the Japanese entertainment and media market, Ishikawa has played a pivotal role in shaping Japan's animation landscape. He has led GONZO through significant milestones, including raising venture and growth capital, and successfully taking the company public on the Tokyo Stock Exchange.

In addition to his work in animation, Ishikawa is an expert in market entry strategies for Japan, as well as business negotiations. He also has extensive experience in fundraising and IPO processes, including successfully buying back GONZO from Bain Capital controlled company.

A former Adjunct Professor of Entrepreneurship at GLOBIS Business School, Ishikawa holds a MSc from the University of Tokyo, for physics (cosmology and astrophysics) and an MBA from INSEAD, where he graduated with the Dean's List honor.
